MAIN TASKS OR ACTIVITIES

- 1. To undertake items of joinery repair and maintenance to both occupied and void/empty properties.
- 2. To construct items of manufactured joinery to the highest standard achievable (within budget).
- 3. To carry out general repair work and items of a multi skilled nature associated with the main job ordered.
- 4. To make good disturbed structures / finishes of a minor nature and report to your Line Manager where other trades persons are required to make good.
- 5. To clear all work areas and remove rubbish after completion of work.
- 6. To undertake all work as directed by your Line Manager and advise of any work which cannot be completed during the initial visit.

- 7. To promptly update records of work completed or delayed due to no access, awaiting materials etc.
- 8. To inspect items of disrepair, assess options for repair and / or replacement, and remedy in the most appropriate manner.
- 9. To take responsibility for the quality of the finished job, life expectancy of repair, and quality of service to the customer.
- 10. To act as the Group's representative with its tenants and residents regarding property issues, arranging appointments as and when required.
- 11. To report any incidents of concern regarding tenants and residents to your Line Manager immediately.
- 12. To effectively communicate with other staff members, tenants, residents, contractors etc either over the telephone, by e-mail or in person.
- 13. Take all reasonable steps to prevent damage to tools and equipment and the possibility of theft.
- 14. To order, collect and take delivery of materials and plant hire equipment required for completion of maintenance work.
- 15. To carry out all duties in accordance with the Group Health and Safety Policy and any other relevant legislation affecting the construction / maintenance industry.
- 16. To follow all Group policies and procedures and attend mandatory training when requested to ensure compliance with Group policies and procedures.
- 17. Ensure you work in accordance with the Equality Act 2010 and the Equality, Diversity & Inclusion Policy at all times
- 18. Carry out any duty which may be, from time to time, requested by your Line Manager, Operations Director of Asset Management, or Chief Executive, commensurate with the position.
