Role Summary

You will carry out a programme of cleaning both internally and externally at the schemes.

You will have a good standard of general education as well as experience in cleaning duties at a large site. Applicants must be able to demonstrate that they are able to undertake the physical aspects of the job.

MAIN TASKS OR ACTIVITIES

1. To provide a complete internal and external cleaning service for all communal areas in line with specifications and the rota.
2. The cleaning of internal windows to an agreed and predetermined standard.
3. Maintain adequate stocks of cleaning supplies at all times and notify Line Manager when orders required.
4. To monitor all faults, damage to property and report these to Repairs / Line Manager.
5. To ensure the basic security of the property.
6. To keep accurate records.
7. To arrange for large items of rubbish to be removed.
8. To support colleagues in the promotion of a positive living environment.
9. Manage emergency situations appropriately by following procedures in accordance with the Group's policies and procedures. To seek Managers advice where required.
10. To provide cover in the absence of other Cleaners or Caretakers where requested
11. Follow all Group values and policies and procedures in accordance with the role.
12. Attend Mandatory training when requested to ensure compliance with Group values, policies and procedures.
13. Ensure you work in accordance with the Equality Act 2010 and the Equality & Diversity Policy at all times.
14. Carry out any other duties which may be, from time to time, requested by the Chief Executive, Deputy Chief Executive or Directors commensurate with the position.
