You will carry out a wide range of domestic gas tasks from responsive repairs, servicing, and boiler installations and ensure that all the gas appliances are serviced and running efficiently to reduce our customers' utility bills. Repairing and diagnosing boiler faults is a key part of the role.

MAIN TASKS OR ACTIVITIES

1. Carry out gas servicing, boiler/central heating repairs and other associated plumbing repairs to the Group's managed properties.
2. Assess options for repair and/or replacement in the most appropriate manner. Take responsibility for quality of finished job, life expectancy of repair, and quality of service to customer.
3. Help and work with residents regarding property issues, arranging appointments with the planners as and when required.
4. Report any incidents of concern regarding residents to the Operations Manager immediately.
5. Report any instances of damage caused to resident's property to the Operations Manager.
6. Effectively communicate with other staff members, residents, contractors etc either over the telephone, by e-mail or in person.

7. Assist other members of the Maintenance Team in the execution of work requiring more than one operative.
8. Use, maintain, clean and store all tools, equipment, vans and first aid boxes etc., provided by the Group, in accordance with manufacturers/supplier's instructions. Bring to the attention of the Performance supervisor any items which are damaged, unfit for use, or need servicing immediately.
9. Order, collect and take delivery of materials and plant hire equipment required for completion of maintenance work.
10. Attend regular training and technical updates as instructed by the Group within the parameters of the tasks and duties.
11. Carry out all duties in accordance with Health and Safety requirements.
12. Provide cover for team members when they are absent from work as and when required.
13. Supervise and coach trainees when required.
14. Take all reasonable steps to prevent damage to tools and equipment and the possibility of theft.
15. Follow all Group policies and procedures in accordance with the role and attend mandatory training when requested to ensure compliance with the Group policies and procedures.
16. Ensure you work in accordance with the Equality Act 2010 and the Equality, Diversity & Inclusion Policy at all times.
17. Carry out any duty which may be, from time to time, requested by the Chief Executive, Deputy Chief Executive or Group Directors, commensurate with the position.
