# JOB DESCRIPTION

## OVERVIEW

As a Neighbourhood Safety Officer you'll provide a service to our customers by working in partnership to help reduce anti-social behaviour within our communities, including taking legal action when necessary.

You will be customer focused with excellent communication skills. You'll need an investigative and enquiring mind with the ability to organise and prioritise your own workload.

Ideally you will be from a housing management background where you have developed skills in dealing with anti-social behaviour issues in a calm and constructive way.

You will have experience of information and evidence gathering, analytical and interviewing skills, alongside an understanding of how people respond in stressful situations.

You'll be responsible for managing caseloads, to make sure we can find effective resolutions in line with our processes, standards, timescales and targets.

## MAIN TASKS OR ACTIVITIES

1. To carry out your role and live the Jigsaw Groups vision and values both internally and externally to deliver the group objectives and achieve organisational goals.
2. Investigate and deal with complaints of anti-social behaviour and other tenancy breaches in an appropriate and objective manner by adopting an approach of prevention, intervention & enforcement strategies.
3. Investigate and deal with safeguarding reports, including concern cards referred by staff / contractors, referrals from external agencies and customers and, where necessary liaise with and refer to other agencies and support the customer as necessary.
4. Prepare and build evidence files for legal applications and represent the organisation in court to effectively secure the required intervention from the courts.
5. To mediate between parties in order to successfully resolve conflicts / dispute.
6. Conduct overt and covert surveillance using specialist equipment and techniques in order to gather evidence of anti-social behaviour and crime. View and preserve surveillance recordings for use in enforcement and legal proceedings.
7. Provide support and advice to witnesses of anti-social behaviour.
8. Attend strategic and other meetings with internal and external agencies in relation to crime and anti-social behaviour. Develop partnerships and promote good working practices with members of the community safety partnership and other relevant agencies.
9. To identify customers with additional needs and give practical support and guidance, liaising with and signposting to other agencies, where necessary to facilitate and manage support that will deliver the most appropriate resolution to the individual circumstances.
10. To operate in a manner that accords with the appropriate statutory guidance, legislation and Jigsaw's Policies and Procedures. To be an active member of the Neighbourhood Safety Team by assisting the continual improvement of the service and support colleagues from other internal departments

11. To be a pro-active member of the team; continually seeking to improve and develop your own skills. Seek to improve processes, keeping value for money as a focus.
12. Undertake such additional roles as are consistent with the above responsibilities at the request of the organisation.
13. This job description is not exhaustive, nor is it intended to be, but should give the post holder a good understanding of the demands of the job. You are expected to be flexible to maintain the good reputation of the teams and will therefore, be asked to carry out other tasks that are unforeseen at this time.
14. Follow all Group policies and procedures in accordance with the role. Complete mandatory training when requested to ensure compliance with Group policies and procedures.
15. Ensure you work in accordance with the Equality Act 2010 and the Equality, Diversity & Inclusion Policy at all times.
16. Carry out any other duties which may be, from time to time, requested by the Chief Executive, Deputy Chief Executive, Group Director or Operations Director or commensurate with the position.

## Candidate Requirements

### Candidate Requirements:

- Full, valid UK driving licence with access to a vehicle for business use.
- Experience of working within an Anti-Social Behaviour field.
- An understanding of the legislation available for tackling anti social behaviour and knowledge of the legal remedies available for breach of tenancy conditions.
- An ability to undertake investigations into complex issues and develop a file of evidence for use in a Court of Law.
- Experience in handling difficult customers in a compassionate and sensitive manner and experience of working with residents who may be vulnerable.
- Experience of information and evidence gathering and compiling that information in an appropriate format.
- Ability to communicate effectively, both verbally and in writing and ability to organise your own schedule, prioritise workloads and work under pressure to meet deadlines.
