Role Summary

The Cyber Security Manager at Jigsaw Homes Group is accountable for the performance, security, and resilience of the Group's data networks and cybersecurity operations. This role provides tactical and operational leadership for the network and security teams, ensuring the Group infrastructure is secure, reliable, and aligned to industry standards and frameworks (ISO27001, NIST CSF, CIS Controls).

The role holder will take a proactive approach to safeguarding information assets, managing risks, leading incident response, and driving continual improvement of the Group's cyber security and network posture. They will collaborate with internal stakeholders, executive leaders, and third-party suppliers to deliver secure, scalable, and compliant technology services.

MAIN TASKS OR ACTIVITIES

1. Lead the data network and cyber security functions, ensuring alignment with organisational goals, risk appetite, and compliance obligations.
2. Develop, implement, and maintain network and security strategies, policies, standards, procedures and user guidance.
3. Provide senior management with reports and dashboards on network performance, security posture, risks, and incidents, offering actionable recommendations.
4. Participate in strategic IT planning, influencing investment decisions and project priorities to strengthen security and resilience.
5. Manage and mentor the network and security teams, ensuring high performance, capability development, and alignment with the SFIA framework.
6. Lead on designing, deploying, optimising, and troubleshooting network and security solutions.
7. Oversee patch management, maintenance, and updates for all network and security infrastructure.
8. Conduct cyber risk assessments and ensure implementation of mitigations in line with corporate risk processes.
9. Support and coordinate internal and external IT audits, penetration tests, vulnerability scans, and red/blue/purple team exercises, ensuring findings are remediated and lessons learned.

10. Implement Third-Party Risk Management protocols, ensuring suppliers meet Jigsaw's security standards throughout onboarding, monitoring, and offboarding.
11. Contribute to Disaster Recovery and Business Continuity planning and testing.
12. Maintain comprehensive documentation of security controls, incidents, breaches, and remedial actions.
13. Build and maintain strong relationships with external vendors, service providers, SOC partners, and auditors.
14. Monitor and manage security awareness training initiatives across the organisation and communicate effectively with stakeholders at all levels to raise awareness of cybersecurity issues, strategies, and mitigations.
15. Influence and negotiate with internal and external partners to adopt best security practices.
16. Follow all Group policies and procedures in accordance with the role and attend Mandatory training when requested to ensure compliance with Group policies and procedures.
17. Ensure you work in accordance with the Equality Act 2010 and the Equality & Diversity Policy at all times.
18. Carry out any duty which may be, from time to time, requested by the Chief Executive, Deputy Chief Executive or Group Directors commensurate with the position.
